

# AAMRI NETWORKS: CONNECTING AND SUPPORTING OUR MEMBERS

Our members often face common challenges that are specific to medical research institutes. AAMRI Networks provide forums for ongoing, open discussion and sharing of ideas among institutes and their professionals.

Communication across the networks is facilitated by AAMRI through private email groups to connect and support our members. Each network has the opportunity to organise an annual networking event to meet in person.

#### **CURRENT AAMRI NETWORKS**



**Finance Network:** Connecting finance managers working at AAMRI member institutes. The network discusses regulatory and policy issues affecting the sector.



**Fundraising and Philanthropy Network:** Connecting Fundraisers, Development Managers, Foundation CEO's, Philanthropy professionals, Marketing specialist and Communications specialist to discuss donor management, benchmarking, experiences and key issues in the medical research sector.



**Gender Equality, Diversity and Inclusion (GEDI) Network:** Connecting members with an interest in advancing gender equality, diversity and inclusion in the medical research sector to discuss major issues and how institutes and the sector are seeking to address them.



**HR Managers Network:** Connecting human resources managers and senior professionals working in human resources (people and culture) at AAMRI member institutes. An annual HR Managers event is usually held in March.



**IT Network:** Connecting Chief Information Officers, IT Managers and other senior IT professionals at AAMRI member institutes. An annual event is usually held in September.



**Legal Counsel Network:** Connecting legal professionals in a confidential setting to discuss key medical research topics and issues. This network is for those working as internal legal counsel for AAMRI member institutes.



**Research Administration Officers (RAO) Network:** Connecting Research Administration Officers and other professionals involved in grant administration at AAMRI member institutes.



**Research Governance and Strategy Network:** Connecting professional and support professionals directly responsible for managing and executing institute strategic activities in research management and development at AAMRI member institutes. This also includes Animal Research Ethics and Human Research Ethics.



**Research Impact:** This Network is set up to support the creation of a Framework for the AAMRI Research Impact Project, as well as facilitate conversation and assist those working on research impact within AAMRI member institutes.

### **AAMRI CONVENTION DAY ONE: MEET OUR SPEAKERS**



**Dr Emma Burrows**Head of Translational
Behaviour Laboratory
The Florey Institute of
Neuroscience and Mental
Health

Dr Emma Burrows is neuroscientist at The Florey Institute of Neuroscience and Mental Health and leads a team aiming to improve diagnosis and treatment of conditions that impact cognition in humans, from autism spectrum disorder to dementia.

Her team's vision is to bridge the gap in translation between animal model systems and clinical research, with the overall aim to deliver real outcomes for people with complex brain conditions. Dr Burrows is an advocate of equity and systems reform in STEMM more broadly and leads local and national efforts to change the culture of academia to one where more people can thrive.

She is a past board director of Women in STEMM Australia, current and co-founding member of Women in Science Parkville Precinct and executive member of the EMCR forum.



Professor Jonathan
Carapetis AM
Executive Director
Telethon Kids Institute

Professor Carapetis is Executive Director of the Telethon Kids Institute in Perth, Western Australia, a Professor at The University of Western Australia, and a consultant paediatrician at Perth Children's Hospital. Previous positions include President, AAMRI; Director, Menzies School of Health Research, Darwin; and Theme Director, Murdoch Children's Research Institute, Melbourne.

In 2018, he was made a Member of the Order of Australia (AM) for his significant contribution to medical research. His research interests include rheumatic fever and rheumatic heart disease, other group A streptococcal diseases, vaccine-preventable disease, Aboriginal child health, child and youth health, development and education, and skin sores and scabies.



Emeritus Professor Ian Chubb AC Australian Academy of Science

Emeritus Professor Ian Chubb was Chief Scientist for Australia 2011 – 2016. Prior to that, he held a number of Vice-Chancellor and deputy Vice-Chancellor positions at the Australian National University, Flinders University of South Australia, Monash University and the University of Wollongong. He has been awarded six honorary doctorates.

In 1999 Professor Chubb was made an Officer of the Order of Australia (AO) and a Companion (AC) in the order in 2006. He was awarded a Centenary Medal in 2001, and was ACT's Australian of the Year in 2011. He was Awarded the Academy Medal of the Australian Academy of Science in 2016 and elected Fellow of the Academy in 2017.



Peter Collins Head Ethics and Integrity (Specialist) WEHI

Peter Collins is the head of ethics and integrity (specialist) at WEHI. He is a former Board member at WEHI, a former head of the national Centre for Ethical leadership, has conducted investigations for Victoria's anti-corruption commission (IBAC) into police corruption as well as a former adviser to a Federal Minister for Health.

Peter is finishing a D. Phil at Oxford on ethics in a health care context and is a regular lecturer at Oxford and business schools in Europe.



Professor Nicholas Fisk AM Deputy Vice-Chancellor Research University of New South Wales



Professor Nicholas Fisk, AM FAHMS FRCOG FRSN is Deputy Vice-Chancellor (Research & Enterprise), overseeing UNSW Sydney's research performance, income, strategy, training, commercialisation and entrepreneurship.

He has served in leadership roles in a number of international and national organisations, including as President of the International Fetal Medicine and Surgery Society, Chair of the Steering Committee of the Association of Academic Health Centers International, and Chair of the Go8 Deans of Medicine Committee. He is a Board Member of Research Australia, a Council member of SPHERE (Sydney Partnership for Health, Education, Research & Enterprise) and chairs the Go8 DVCR Committee and NewSouth Innovations.



Professor Elizabeth Hartland Director and CEO Hudson Institute of Medical Research

Professor Elizabeth Hartland is the Director and CEO of Hudson Institute of Medical Research in Melbourne and Head of the Department of Molecular and Translational Science at Monash University. She is a leading Australian microbiologist with a research interest in defining the strategies used by pathogenic bacteria to evade immune detection. She was an inaugural Australian Research Council Future Fellow at the University of Melbourne and subsequently held key leadership positions at the Doherty Institute for Infection and Immunity and the University of Melbourne.

She is a current member of NHMRC Council (2021-2024), member of the Australian Association of Medical Research Institutes (AAMRI) Board and Chair of VicAAMRI.



**Professor Natasha Harvey**Director
Centre for Cancer Biology

Professor Natasha Harvey is Director of the Centre for Cancer Biology. Natasha received her PhD in cell and molecular biology from the University of Adelaide and undertook postdoctoral training in developmental biology at St Jude Children's Research Hospital, USA. During her postdoctoral training, Natasha's studies focussed on embryonic lymphatic vascular development and in particular, defining the role of the homeobox transcription factor PROX1 in programming cell identity during development.

Natasha returned to Adelaide in 2005 to establish her independent research program at the Centre for Cancer Biology. Her work aims to understand how the lymphatic vasculature is constructed during development and how this process "goes wrong" in human pathologies including cancer, vascular malformations and lymphoedema.



**Professor Anne Kelso AO**Chief Executive Officer
National Health and
Medical Research Council

Following her PhD at the University of Melbourne, Professor Kelso undertook research in immunology at the Swiss Institute for Experimental Cancer Research, WEHI and the Queensland Institute of Medical Research. From 2000-2006, she was Director/CEO of the Cooperative Research Centre for Vaccine Technology, then Director of the WHO Collaborating Centre for Reference and Research on Influenza from 2007 until her role with NHMRC in 2015. She was appointed Officer in the Order of Australia in June 2007 for service to science.

Professor Kelso is a member of several Government and international committees, including the Australian Medical Research Advisory Board, Board of the Global Alliance for Chronic Diseases and the Board of Trustees of the International Human Frontier Science Program Organization.



**Ken Knight**Research Impact Manager
Murdoch Children's
Research Institute

Ken Knight is a leader, practice specialist and educator in the fields of research impact, engagement and knowledge translation (KT). He is Research Impact Manager at the Murdoch Children's Research Institute, where he leads an award-winning program to build capacity, capability and an enabling culture for research impact and engagement. He holds an Honorary research role in the Department of Paediatrics at The University of Melbourne, where he teaches approaches to KT, engagement and impact.

Ken is Co-Chair of AAMRI's Impact Working Group and Community of Practice and was part of the team that established the first Research Impact Framework for the Australian health and medical research institute sector.



Professor Jason Kovacic Executive Director Victor Chang Cardiac Research Institute

Jason Kovacic graduated from The University of Melbourne Medical School in 1994 and undertook residency and cardiology specialty training at St. Vincent's Hospital in Sydney. Jason completed a PhD at the Victor Chang Cardiac Research Institute, before relocating to the USA and undertaking a postdoctoral fellowship at the NIH. He also established a large clinical practice as an interventional and clinical cardiologist.

In early 2020, Jason became Executive Director of the Victor Chang Cardiac Research Institute. He currently holds the positions of the Robert M. Graham Chair and Professor of Cardiovascular Research at University of New South Wales, and continues his appointment as Professor of Medicine (Cardiology) at Icahn School of Medicine at Mount Sinai, New York, USA.



**Kirk Leech**Executive Director
European Animal
Research Association

Kirk is the Executive Director of the European Animal Research Association (EARA), a communications and advocacy organisation whose mission is to uphold the interests of biomedical research and healthcare development.

Kirk is a regular writer and presenter with over 500 articles and appearances on television and radio.

Previously he worked in government affairs for the Association of the British Pharmaceutical Industry and Understanding Animal Research. Before UAR Kirk acted as a consultant for the White House Writers Group a strategic communications consultancy based in Washington, DC. Prior to this Kirk worked in the eastern tribal areas of Gujarat India on influencing public opinion on the economic benefits of the Narmada dam and in opposing the imposition of wildlife sanctuaries on tribal land.



Professor Fabienne Mackay Director and CEO QIMR Berghofer Medical Research Institute

Professor Fabienne Mackay is the Director and CEO of QIMR Berghofer Medical Research Institute. She was the inaugural Head of the School of Biomedical Sciences and Head of the Department of Pathology in the Faculty of Medicine, Dentistry and Health Sciences, at the University of Melbourne since 2015. She was elected as a Fellow of AAHMS in 2016.

Professor Fabienne Mackay served six years on the prestigious Medical Advisory Board of the Gairdner Foundation in Canada. She is on the board of AAMRI and Health Translation Queensland, and on the Council of AAHMS and on the NHMRC research committee. Her research relates to autoimmune diseases such as lupus and leukemia. She is the world's most highly cited scientist in the BAFF (B cell activating factor) field.



**Professor Graham Mann**Director
John Curtin School of
Medical Research

Professor Graham Mann joined the John Curtin School of Medical Research in 2019, bringing a national and international reputation in basic and translational cancer research. After graduating in Medicine and training in medical oncology, he studied cell proliferation and established himself at the Westmead campus of Sydney Medical School as a full-time researcher in cancer genetics focussing on familial melanoma.

Graham helped develop and lead signature genetic epidemiology projects such as the Australian Melanoma Family Study, the international GenoMEL consortium and the Australian kConFab breast cancer genetics consortium. He initiated and co-led the Australian Melanoma Genome Project, the MelCOR Australian Clinical Outcomes Register project, and the ACRF Centre for Excellence in Melanoma Diagnosis project. He has contributed to the National Centre for Indigenous Genomics as its interim Director since 2020.



Professor Kathryn North AC President, AAMRI Director, Murdoch Children's Research Institute

Professor Kathryn North AC is Director of the Murdoch Children's Research Institute and the David Danks Professor of Child Health Research at The University of Melbourne. In 2020, she joined the Board AAMRI as President-Elect. She is trained as a physician, neurologist and clinical geneticist, and is a national and international leader in Genomic medicine.

In 2014, Professor North was appointed as Co-Chair of the Global Alliance for Genomics and Health and she leads the NHMRC-funded Australian Genomics Health Alliance. She chaired the NHMRC Committee from 2012-2018, and the International Advisory Board of the Great Ormond Street Institute of Child Health (UK) since 2015. She is a member of the Board of the Victorian Comprehensive Cancer Centre. In 2014, she was appointed as a Foundation Fellow of the Academy of Health and Medical Sciences, and in 2020 joined the Academy's Board.



**Dr Shanthi Ramanathan**Health Research,
Economics Impact
Assessment Specialist
Hunter Medical Research
Institute

Shanthi Ramanathan is a leading research impact and research impact assessment practitioner in Australia. She is the Research Impact Lead at the Hunter Medical Research Institute and a conjoint academic with the University of Newcastle's College of Health, Medicine and Wellbeing.

She leads a team who apply the comprehensive Framework to Assess the Impact of Translational Health research to local, national and international research projects, programs, research collaboratives and funding schemes; build impact and translation literacy, capability and culture both at HMRI and beyond, and work with funders to embed impact planning and evaluation into their various grant schemes. She has authored over 10 peer-reviewed publications, facilitated 25 workshops and delivered 24 presentations to over 1,900 researchers, clinicians, policymakers and consumers. Shanthi is Co-Chair of AAMRI's Impact Working Group and Community of Practice.



Professor Sir John Savill Executive Director Melbourne Academic Centre for Health

John Savill has been Executive Director of the Melbourne Academic Centre for Health (MACH) since July 2019, having served in the UK as an honorary consultant in renal and acute medicine from 1990 to 2018. In 1998 he set up and became the first Director of the University of Edinburgh/Medical Research Council Centre for Inflammation Research. In 2017 he was appointed to the Regius Chair of Medical Science by HM The Queen, an appointment he still holds part-time.

He was a member of the Medical Research Council from 2002 to 2008 and chaired two Research Boards. Between 2006 and 2008 he chaired the international panel that established NIHR Biomedical Research Translation Centres across England, with a five-year budget approaching £1bn. He was knighted in the 2008 New Year's Honours List for services to clinical science.



Professor Peter Schofield A0 CEO Neuroscience Research Australia

Professor Peter Schofield has served as CEO of Neuroscience Research Australia (NeuRA) since 2004, as an AAMRI Board member since 2019 and is the inaugural Chair of the NSW Chapter of AAMRI. He presented the AAMRI submission and gave evidence to the NSW Parliamentary Inquiry on the use of animals in medical research which was held in May 2022.

He was appointed an Officer of the Order of Australia in 2019 for distinguished service to medical and scientific research in the field of neuroscience, and to professional institutions.

Professor Alison Venn is an epidemiologist with research interests in chronic disease, cancer and reproductive health. She is Director of the Menzies Institute for Medical Research, University of Tasmania, and a member of the AAMRI Board and NHMRC Council.

In 2011, Professor Wesselingh took up the position as the inaugural Executive Director of the South Australian Health and Medical Research Institute (SAHMRI). He is Chair of the NHMRC Research Committee and Director NHMRC Council and President of the Australian Academy of Health and Medical Sciences Limited (AAHMS).

Professor Wesselingh is an Infectious Diseases Physician and researcher in HIV, vaccine development and the impact of the microbiome on human health. He was Dean of the Faculty of Medicine, Nursing and Health Sciences at Monash University, from 2007-2011. Prior to taking up the Deanship, he was Director of the Burnet Institute.
